

## The birth of the EUsers network

In July 2014, the Education, Audiovisual and Culture Executive Agency (EACEA) of the European Commission has awarded the project 'Services of general interest in the EU: A citizens' perspective on public versus private provision (EUsers)'.

The objective of the EUsers is to encourage the diffusion of innovative teaching approaches, applied research and policy debate on services of general interest in the European Union from a citizens' perspective, by creating a network of six universities.

Started on the 1<sup>st</sup> of September 2014, the EUsers will involve a series of activities – seminars, summer school, workshops, coordination meetings, e-book publications – over a period of three years (until 31.08.2017).

The EUsers network's activities will focus mainly on network SGI such as – for instance – energy, telecommunications, transport and environmental services.

After six months from its starting (1. 09. 2014), the EUsers network has delivered the following activities:

- ✓ The first *Coordination meeting* was organized in Milan to launch the activities of the network.
- ✓ A meeting was held in Milan between the team of the University of Milan and the Project Manager of Jean Monnet Programme.
- ✓ The series of 45 seminars was launched on 12<sup>th</sup> of December 2014.
- ✓ A <u>website</u> has been created to disseminate the EUsers activities and to share papers and materials.
- ✓ The first Workshop (out of the two planned) is scheduled in Milan on 25-26<sup>th</sup> of June 2015.



## **EUSERS MEETINGS**

### The first EUsers coordination meeting

The first Coordination meeting of the EUsers network took place on the 23rd of October 2014. During the meeting, the six Universities discussed in details the activities that will be implemented over the three academic years (September 2014 - August 2017), including the organization of 45 seminars, a summer school, two workshops, a second Coordination Meeting, the launch of the website and the publication of the e-book.

Also, the six Universities briefly illustrated the kind of teaching courses which will be involved in the EUsers programme of activities. They agreed to involve as many students as possible (e.g. undergraduate students, PhD students, post-doctorate) as well as representatives from civil society and policy makers during all the activities. They are committed to ensure multidisciplinary synergies among academic disciplines in the EUsers' activities. In carrying out these activities, synergies with the <u>CIRIEC</u> network will be explored.

The next Coordination meeting is scheduled in June 2015 in Milan during the first workshop organized by the EUsers network.

## EUsers network meets the EACEA officer in Milan

On the 25th of November 2014, a meeting was held in Milan between the team of the University of Milan and Ms Piedad Rivas – Project Manager of Jean Monnet Programmes at EACEA.

During the meeting, the Project coordinator – Prof. Massimo Florio (from the University of Milan) – presented the six universities of the EUsers network, the objectives to be achieved and the activities planned. Also, preliminary structure of the website was showed and discussed with the participants of the meeting.

## **EUsers network meets the EACEA officer in Brussels**

A new meeting between EUsers network and EACEA officers took place in Brussels on 22<sup>nd</sup> January, 2015.

Prof. Massimo Florio (University of Milan) met Maria Victoria de Yturriaga Saldanha, the new Project Manager - since January 2015 - of the Erasmus +, Jean Monnet Programme.

During the meeting, the timeplan of the EUsers activities was discussed. Prof. Florio announced the launch of the seminar series and of the website.

### XIV MILAN EUROPEAN ECONOMY WORKSHOP

## Major Public Enterprises in a global perspective

25-26th of June 2015

Annually organized by the University of Milan, the *European Economy Workshop* - in view of its XIV edition - will focus on the activities of the EUsers network.

In particular, it will present preliminary knowledge developed on the empirical analysis of the different mode of provision of services of general interest, with a specific focus on public providers.

The aim is to contribute to a systematic analysis, country by country, on some key research questions:

• What is the extent of the survival or expansion of the public enterprise (PE) in a global perspective, particularly as far as large enterprises are concerned?

- Who are the major players at national and international level?
- How do they perform? How is the control of government implemented?
- What is the mission assigned by governments to the major players?
- To what extent are PE of national significance transforming themselves in multinationals?

The workshop is organized in collaboration with <u>CIRIEC</u> network and will take the form of an in-depth discussion of a set of invited papers.

Around 20 country papers will be presented. Key note speakers will be:

## THE CALL FOR PAPERS



The EUsers network periodically launches call for papers with the aim of collecting and capitalising the knowledge on SGI and specific related issues. Selected papers will be disseminated through publications.

In view of the XIV Milan European Economy Workshop, the EUsers network has launched a call for paper aimed at collecting *country analysis* of the role and performance of major public enterprise (PE), and the policy trends about the current relationships between government and PE.

The country papers will be focused on PEs having at least a national scope of operations, and/or an international dimension. It will identify the major PEs in the country, discuss their performance (particularly during years after 2000 and the Great Recession of 2008), current policy trends and future perspectives.

## TEACHING ACTIVITIES

As part of the EUsers teaching activities, the University of Milan has organised a new course in 'European regulatory economics' (ERE) (January-March, 2015).

The course was built on the knowledge acquired during Prof. Florio Jean Monnet Chair "Ad Personam" of "European Union Industrial Policy".

It focused on SGI, in particular network industries and on the interplay between provision and regulation.

The objective of the course was an introduction in economics policy of network and industries in the European Union.

The reform paradigm that was discussed includes privatization, vertical disintegration, price regulation and liberalization.

The sectors considered include electricity, gas and telecoms

The course was held by Prof. Florio and Prof. Chiara Del Bo.

It was structured into the following three modules:


- 1. Economics of regulation
- 2. The policies
- 3. Country case studies.


During the third module, students have been divided into groups and asked to perform a country analysis of reforms in the sectors considered.

Country reports prepared students included:

- A brief discussion of the national context, highlighting the features relevant for subsequent analysis in the period and the relevant sector.
- Presentation of the characteristics of the sector in the country, examining the supply demand for the service, also from the technological point.
- Changes in consumer prices over time, for different types of user.
- Development of sector reforms.
- Comparative analysis of price trends, reforms and other factors that may have an impact on with any prices, hints consumer satisfaction.
- Conclusions

The most interesting country reports have been published on the EUsers website (see section Students club).
